Food Scrap Diversion and Your Bottom Line

Food scraps aren't *waste*—they're the necessary ingredients for making compost! **And diverting food scraps to composting can provide some sound economic benefits for your business, too.**

- Diverting food scraps to composting can reduce the amount of trash you pay to have hauled to the landfill.
- We'll train your staff and supply all the materials you need to get started for FREE—including transportation and compost tipping fee costs for the first month you take part in the program.
- Diverting food scraps offers your restaurant/cafeteria/school a “green” image—influencing customers, staff and/or families.

Here are some of the facts:

FACT: Reducing the amount of trash you produce can reduce your trash bill. Food scraps make up between 56% and 60% of restaurant waste, by weight.* By diverting all those food scraps to composting, your dumpster won't fill up as often and your garbage won't be as smelly! Both factors can reduce the number of dumpster “pulls” you'll need—which could reduce your trash bill.

FACT: It costs nothing to try the program! We provide everything you need to get started—staff training; educational signs to post in the kitchen and wait staff areas; free transportation and coverage of compost/food scrap tipping fees for the first month; help in understanding and renegotiating your trash contract; and sturdy 48-gallon totes for collecting food scraps.

After the one-month trial period, you'll be billed for food scrap hauling and tipping fees. But the food scrap/compost tipping fees are lower than the trash tipping fees. District staff can help you figure out your costs and how the program can impact your business for the better.

FACT: Local agriculture has strong supporters in Central Vermont, and composting helps to complete that cycle—returning food scraps to the soil to grow more food. A “green” image can be positive for your business, too!
